

# WATER BOTTLE CAGE INSTRUCTIONS



Thanks for buying a Whisky Parts Co. product. Whisky makes parts that are designed to keep on delivering, ride after ride, year in and year out.

**▲ WARNING:** Cycling can be dangerous. Bicycle products should be installed and serviced by a professional mechanic. Never modify your bicycle or accessories. Read and follow all product instructions and warnings including information on the manufacturer's website. Inspect your bicycle before every ride. Always wear a helmet.

## Compatibility and Intended Use

Whisky Parts Co. bottle cages are compatible with traditional two-bolt fit and placement on most bicycles.

## Tools Required

- 4mm hex wrench or hex wrench appropriate for the bolts used
- Grease
- Torque wrench that measures in Nm

## Installing the Whisky Bottle Cage

1. Remove bolts that are already on the bike.
2. Grease the threads of the bolts before reinstalling.
3. Place the bottle cage over the bolt holes.
4. Reinstall the bolts and tighten to 4Nm.

**▲ WARNING:** Where you position the cage will depend on personal preference, frame size and geometry. Make sure the cage does not interfere with the function of your bicycle BEFORE attempting to ride.

## Ongoing Maintenance

Periodically check to make sure the attachment bolts are tightened to 4Nm.

## Three Year Warranty

Whisky Parts Co. warrants this part against manufacturing defects in materials, craftsmanship and design for a period of five years from the date of purchase for only the original owner with accompanying proof of purchase.

This warranty applies to and covers only Whisky Parts Co. branded product.

### Warranty Exclusions:

- Installation of components, parts, or accessories not originally intended for or compatible with Whisky Parts Co. products
- Damage or deterioration to the surface finish, aesthetics, or appearance of the product including but not limited to paint damage
- Normal wear and tear
- Labor required to remove and/or refit and re-adjust the product within the bicycle assembly
- Damage to carbon fiber caused by any carbon assembly paste

This limited warranty is expressly limited to the repair or replacement of a defective product, at the option of Whisky Parts Co. and is the sole remedy of the warranty. This limited warranty applies only to the original purchaser of the product and is not transferrable. This warranty applies only to products purchased through an authorized dealer or distributor. In no event shall Whisky Parts Co. be liable for any loss, inconvenience or damage, whether direct, incidental, consequential, or otherwise resulting from breach of any express or implied warranty or condition, of merchantability, fitness for a particular purpose, or otherwise with respect to Whisky Parts Co. products except as set forth herein.
